A LAW TO AUTHORISE THE ISSUE FROM THE CONSOLIDATED REVENUE FUND OF ONDO STATE OF NIGERIA, A SUM OF ONE HUNDRED AND EIGHTY-SEVEN BILLION, EIGHT HUNDRED AND FIFTY-EIGHT MILLION, FIVE HUNDRED AND TWENTY-FIVE THOUSAND, TWO HUNDRED AND SEVENTY –THREE NAIRA (₦187,858,525,273.00) ONLY, OUT OF WHICH THE SUM OF TEN BILLION, FIVE HUNDRED AND EIGHT MILLION, TWO HUNDRED AND FORTY-SIX THOUSAND, NINE HUNDRED AND THIRTY-THREE NAIRA, NINETY KOBO (₦10,508,246,933.90) ONLY IS FOR DEBT SERVICE; THE SUM OF FOURTEEN BILLION, ONE HUNDRED AND SEVENTY-NINE MILLION, NINE HUNDRED THOUSAND, SEVENTY-TWO NAIRA, FIFTY-TWO KOBO (₦14,179,900,072.52) ONLY IS FOR STATUTORY TRANSFERS; THE SUM OF EIGHTY-TWO BILLION, SEVEN HUNDRED MILLION, THREE HUNDRED AND THIRTY-FOUR THOUSAND, NINE HUNDRED AND FORTY-THREE NAIRA (₦82,700,334,943.00) ONLY IS FOR RECURRENT EXPENDITURE WHILE THE BALANCE OF EIGHTY BILLION, FOUR HUNDRED AND SEVENTY MILLION, FORTY-THREE THOUSAND, THREE HUNDRED AND TWENTY-THREE NAIRA, FIFTY-EIGHT KOBO (₦80,470,043,323.58) ONLY IS FOR CAPITAL EXPENDITURE FOR THE SERVICES OF ONDO STATE OF NIGERIA FOR THE YEAR ENDING THIRTY-FIRST DAY OF DECEMBER, TWO THOUSAND AND TWENTY.

BE IT ENACTED by the Ondo State House of Assembly in this Legislative Session convened as follows:-

1.
